Registration/Payment Procedures:

There is a NON-REFUNDABLE registration fee of \$100.00 per child.

Monthly fees remain the same regardless of holiday or school closing. Payments are due on the 30th of the month. A LATE FEE of \$15.00 will be charged to your account if any payment is not received within 10 days from the payment due date. **Extended Care payments MUST be kept separate from school tuition.**

AGREEMENT

I agree to pay the monthly fee on the 30th of each month for 10 months beginning with August 30th. It is my understanding that if payment is 30 days delinquent, my child/ren may not attend until payment is received and delinquent payments will result in withholding school reports and records. I also understand that the registration fee is non-refundable. However, if a new registrant is not accepted by the school or is withdrawn before official notice of acceptance has been sent, 50% of the required registration fee will be refunded.
