### Registration/Payment Procedures:

**There is a NON-REFUNDABLE registration fee of \$100.00 per child.**

Monthly fees remain the same regardless of holiday or school closing. Payments are due on the 30<sup>th</sup> of the month. A LATE FEE of \$15.00 will be charged to your account if any payment is not received within 10 days from the payment due date. **Extended Care payments MUST be kept separate from school tuition.**

## AGREEMENT

I agree to pay the monthly fee on the 30<sup>th</sup> of each month for 10 months beginning with August 30<sup>th</sup>. It is my understanding that if payment is 30 days delinquent, my child/ren may not attend until payment is received and delinquent payments will result in withholding school reports and records. I also understand that the registration fee is non-refundable. However, if a new registrant is not accepted by the school or is withdrawn before official notice of acceptance has been sent, 50% of the required registration fee will be refunded.
